



animals resulted in rather low daily gains, the experimental data did not allow the calculation of the maximum potential growth. It can be seen, however, that the large difference between these two assumptions has a large influence on the values of $k_{w,0}$. The assumption that the measured points are located on the more linear part of the SSF. Lower rates values for A are unlikely to occur, since growth rates of 1500 g per day and more have been measured.

Figure 2 shows that $k_{w,0}$ increases with protein content of the ration. There seems to be no decline in this regression up to 2.5 g NMF/ME (\approx 7% crude protein).

On the other hand it is improbable that $k_{w,0}$ has exceeded values of 0.5 - 0.6 in farm animals.

The limiting value up to which the protein content of the ration can be raised without running into disadvantages in protein synthesis, thus figure can be used for economic evaluation of the ration as an additional value. Since the sum of ME-contents of the single feed-stuffs, however, is not only influenced by the nature of the ration, but also by protein-energy ratio, protein quality and essential amino acids. The influence of the other factors can be analyzed by regression analysis.

Figure 2 shows an example of a regression between protein energy ratio (N/MF) and $k_{w,0}$, derived from experiments with growing bulls (Oster, 1975). Oster and


